# Fiscal 2024 Agency Overview

# **Policy and Oversight**

Upon the arrival of the new administration, new policies were enacted to enhance the efficiency of the office:

- Ensuring notice posting is being done on individual doors for Evictions and Tenant Hold-Overs.
- Tenants can now call and receive their date of eviction.
- Rental Fraud Investigation Unit, that looks in to fraudulent licenses.
- Our office is also in the process of updating our General Orders, as to make them coincide with the highest standards of policing.





# **Technology and Social Media**

- A major goal of the new administration was to bring the office to the 21st century with technology that allows the office to be more effective.
- Some of these innovations include the following:

- Web based applications for incidents, employment application and domestic violence interviews have been deployed but are suspended pending action by purchasing.
- Real time location tracking for field personnel and vehicles has been procured and introduced on a beta project for only \$5,000.00 per year thanks to assistance from the FBI.
- Real time field reporting has been deployed to Special Operations Team and our Domestic Violence Unit
- Our Dispatch system has been enhanced to give our dispatchers the same tools as the 911 center
- Agreement has been signed for a 911 Cad feed for immediate notification of 911 calls coming from the area surrounding the court facility. Project is currently being held up by BCIT.
- 20 laptops have been distributed to the Special Operations Personnel. Digital traffic ticket and crash investigation training has been scheduled for Mid-June of 2023.




# **Officer Safety and Wellness**

- At the beginning of the administration there was no Health and Wellness program in the office.
- In order to assist with the Health and Wellbeing of Deputies and Staff we have worked closely with Merritt Fitness and NAMI (National Assocation on Mental Illness) to develop programs for physical and mental wellness.
- With NAMI, we are seeking to have Peer to Peer Counseling training.
- With Merritt we are working on an 80% reduced membership for Deputies and Staff, that would also include nutritional counseling.
- We are looking to have these programs stood up by July 2023.











# **Deputy Sheriff Enforcement**

#### Pillar: Enhancing Public Safety

Service Number: 882

FY24 Rec. Budget: \$14,238,045

**Service Description:** This service is responsible for serving all orders originating from Circuit Court such as warrants, attachments, foreclosures, evictions, temporary protective orders, and levies.

### **Major Budget Items**

The recommended budget includes funding for pay increases as part of the labor agreement between the City and union covering staff from the Sheriff's Office. The recommended budget includes \$300,000 for the Sheriff's Office to invest in additional staffing resources and IT investments.





### **Service of Protective and Peace Orders**

**Pillar:** Enhancing Public Safety

Service Number: 883

**FY24 Rec. Budget:** \$2,687,682

**Service Description:** This service is responsible for serving peace and protective orders issued by the District and Circuit Courts.

The recommended budget includes funding for pay increases as part of the labor agreement between the City and union covering staff from the Sheriff's Office.





# District Court Sheriff Services & Child Support Enforcement \*

Pillar: Enhancing Public SafetyService Number: 884FY24 Rec. Budget: \$2,938,923

**Service Description:** This service serves all rent process issued from the Baltimore District Court, including the performance of evictions by court order. Deputies also serve and enforce District Court writs, summonses, attachments, and levies.

**Service Description:** This service serves child support process warrants in Baltimore City for the State's Child Support Enforcement Administration in the Department of Human Resources.

# **Courthouse Security**

### Pillar: Enhancing Public Safety

#### Service Number: 881

### FY24 Rec. Budget: \$4,850,386

**Service Description:** This service provides courthouse, courtroom and perimeter security for the City's two Circuit Court buildings and the Juvenile Justice Center. Court Security Officers screen all members of the public who enter the buildings for weapons and contraband; provide courtroom security; and protect judges, courthouse employees, witnesses, defendants and member of the public.

### **Major Budget Items**

The recommended budget includes funding for pay increases as part of the labor agreement between the City and union covering staff from the Sheriff's Office.





# **Court Security Cont..**

New Programs:

- Outside Court Facility Patrol Function -291 tickets
  issued
- New Court Clothing Policy Allows Trials not to be delayed but provides enhanced screening for attempted smuggling of substances.
- Narcotics Detection K-9
- Civil Court Protection during trials increases security
- Civilian Door Screener trained as Special Police



\*With our enhanced Court Clothing Program we have been able to intercept over \$50,000 worth of Suboxone that was attempted to be smuggled in to the prison system.





# **Field Services**

- Ensuring notice posting is being done on individual doors for Evictions and THOs.
- Tenants can now call and receive their date of eviction.
- Rental Fraud Investigation Unit has been created in order to detect fraudulent lead certificates and rental licenses.
- Currently our office is putting together a social worker program to provide emergency services to families and residents, and is currently in the process of reclassifying positions for hiring.

# **Sheriff's Office Concerns**

### Age of Current Fleet:

Currently, the Baltimore City Sheriff's Office has not received a new vehicle from Fleet Management in 6 years. Although we pay into the same system is not given any priority when it comes to new vehicles.

### **Pay Disparity:**

 Our deputies receive the same training, same certifications, and preform the same duties in the same city, yet earn 20% less than BPD officers. This creates incredible recruitment and retention issues, and decrease public safety.

### **Technology and Body Camera Implementation:**

 Coming into the office, there was a resounding lack of technology. This includes a lack of infaustructure to bring in a body camera program.

### Health and Wellness:

• There is currently a lack of a Health and Wellness program, as well as adequate facilities. Currently, there is no locker room for the Deputies, nor is there a gym for them to use.
