## RE: Fiscal Year (FY) 2024 Budget Hearing Format and Schedule

Please see below format and schedule for the FY2024 budget hearings. The City Council's Ways and Means Committee looks forward to your participation and the opportunity to continue working together. In the meantime, you will be receiving guidance from the BBMR Budget Director in the coming weeks regarding: 1) schedule and format of hearings; and 2) submitting updated org charts and cell phone numbers for key personnel in your agency / department to the Committee, by no later than May 19, 2023.

#### Format

- 1. All hearings will be conducted in City Council Chambers at City Hall, in-person. At this time there is no hybrid hearing option, meaning that all participants are expected to be present in City Council Chambers for the duration of their respective agency's time slot. The Committee will not take testimony from agency officials attending virtually.
- 2. All protocols related to COVID-19, bringing a government issued identification card, metal detector passage, etc. will remain in place. These protocols apply to everyone so please plan appropriately and arrive early if necessary.
- 3. All hearings are open to the public to attend in-person.
